There are several reasons for this exciting development including; the need to be seen on a national scale in the sponsorship space; the need for our brand to reflect what we offer and the position we hold in the agricultural event space; and to support our move to create some exciting new exhibitions at the Show to better reflect our mission to promote excellence and innovation in the agri-sector. We need to future-proof our event to mitigate the very real threat of a bad-weather Show and this is the best step forward. We also believe that by future proofing our event, we will be helping to grow the A&P movement in New Zealand as a whole by creating a nationally-recognised event in the South Island.

The Endurocross motorcycle event is another crowd pleaser and just gets more popular.

My year as President allowed me to see much more of the Show and I can now clearly see of all the voluntary hours and work that goes into the various sections to make the Show such a success.

The support of all the Past Presidents was also much appreciated. You were a great help to me with your advice and wisdom.

To my Vice Presidents, Tim Black and Chris Herbert, it's been great working with you both and getting to know you better. Thank you for making my year as President easier.

In closing, it has been an honour and a privilege to have been your President for the past year. I wish Tim and Chris and all involved all the best for a great 2018 Canterbury A&P Show, soon to be known as The New Zealand Agricultural Show.

Chairman's Report

This is my first report as Chairman of the Board of your Association. My early impressions of a vibrant, energetic, passionate, but highly fragile business, haven't changed.

We have had a good year, with a highly successful Show, blessed by good weather, great crowds and no major operational problems. We also achieved our approximate break even budget (including depreciation) within a few thousand dollars. To me, this highlights the inherent risk in this business, in that we only achieved this modest result, even with most things going in our favour. The perennial prospect of inclement weather, demands we continue to work hard on trade, sponsorship and admission pre sales, to diminish the ever present risk to our Balance Sheet.

To this end, we have a number of exciting initiatives underway, with our imminent rebranding, the development of our Science & Innovation precinct, and potential new avenues of funding with the establishment of ChristchurchNZ, as the City Council's facilitator of Mega and Major Events, and hopefully improved access to Central Government funding, through the promotion of our national brand. Another major opportunity exists with the upcoming development of the Wigram Road land, granted by the council in exchange for the inconveniences of the Ngā Puna Wai development.

There have also been a number of significant challenges this year. The expiry of the lease with the Canterbury Saleyards Company initiated quite some energy, in promoting the alternative concept of a licence for multiple users of our facility, for the ultimate betterment of the whole industry. In the event, the Saleyards company have now chosen to renew the lease, but we continue to pursue the benefits of the wider opportunity. Operationally, the Ngā Puna Wai development and its surrounding works have posed challenges for our staff and contractors, and we are hopeful for significant recovery of both direct and indirect costs associated with these changes. We have on-going dialogue with the Royal Agricultural Society and look forward to holding another Royal Show in the near future. We continue to pursue options to improve facilities for volunteers, staff, and contractors. These options are still in the investigatory stage but will be, most likely, subject to receiving substantial grants to assist with funding costs.

I thank the board for their support, guidance and wisdom. There have been a number of Board changes this year. Colin Notley retired from the Board and was presented with a Life Membership at the Show in November. His contribution over 15 plus years has been immense.

Previous Chairman, Ben Tothill, also resigned after last year's Annual General Meeting. Ben's contribution over the years has been significant, both as Chairman and through his expert legal guidance on a myriad of mainly property and lease related matters. Looking forward, and in an effort to broaden the skill base of the Board, we have appointed Mark Clarkson, recently retired Managing Director of ANZCO Foods, who joined the board late in the year, and we welcome his significant expertise and industry knowledge. More recently, we have invited Melissa Davies to also join the Board. Melissa originally hails from a Southbridge farming family but brings us some real strategic business, marketing and technical skills. We held a board Planning Day in December to help focus attention and resources on a coherent and measurable path ahead.

I want to also acknowledge the extraordinary contribution of the Committee and volunteers. Without them we would not have a Show or a business. My thanks particularly to outgoing President, Peter Gilbert for his leadership, and I welcome Tim Black into the seat for the upcoming year.

My sincere thanks also to Geoff Bone and his team, at Beck & Caul, who tirelessly work to produce a professional and well-managed Show. Also the outstanding work of our Operations team of Dugald Thomas and Nigel Allen (who has just retired), who daily manage an increasingly busy Park.

I wish to acknowledge our sponsors, trade clients and other stakeholders including the on-going support of the Christchurch City Council. We are 'bound at the hip', on a number of fronts with the Council, and I thank Mayor Dalziel and Deputy Mayor Turner for their encouragement and assistance. We again hosted many members of Parliament at the Show this year, including, appropriately, local MP and new Minister of Science & Innovation, Megan Woods.

Finally, I believe we have an exciting, albeit challenging, future. We are the 'biggest show in town', on the Christchurch event calendar, but we need to increase our presence in the national psyche. We must continue to innovate if we are to flourish and grow. We must maintain our appeal to the citizens of Christchurch and Canterbury, so we can continue to educate, connect and inform our Friday visitors, and help bridge the divide between town and country. Finally, and most importantly, we must showcase the 'cutting edge' of agricultural innovation, and build our agribusiness and farming brand, so we continue to be, a 'must be there' event, amongst our rural stakeholders.

Event Directors' Report

The 2017 Canterbury A&P Show was an enormous success thanks to the extraordinary efforts of our volunteers, members, operations team and committees. We faced many challenges in 2017 that included a complete redesign of one of New Zealand's largest carparks. Successfully getting our 100,000 visitors into the site and around the exhibits, competitions and features was a mammoth effort and I would like to thank everyone that contributed to its success.

In 2017 we succeeded in delivering stage one of a new focus on Science and Innovation with a modest marquee dedicated to agricultural innovation. The intention in 2018 is to build on the support received and scale this up significantly by partnering with local and central Government. Our Live Wool Auction grew in stature having been inaugurated the year before and now becoming cemented as a regular part of the Show. Bev Forester and her team of volunteers were instrumental in adding a Wool Fashion Parade, further enhancing the Wool section and delivering on our three year plan to breathe more life and energy into a wonderful section. We also completed the planning for our 2018 plans to rebrand and grow our National profile as The New Zealand Agricultural Show – the largest agricultural show in the country. Our shared goal is to continue developing the rural focus of the Show as New Zealand's greatest showcase of all things rural, whether they be animal genetics in the Showing sections, rural sports or machinery and technology. It's the rural experience that our urban audience wants to feel when they arrive and for the volunteers it's the opportunity to engage with their community and share that rural experience with others.

Whilst we have delivered a small loss of \$6,027 after depreciation we did deliver a pre depreciation surplus of \$94,115 compared to a loss of (\$21,944) the year before. I would like to thank the volunteers, committees and management staff for their contribution to achieving an outstanding show experience in 2017.

Our shared vision to improve the event experience for visitors, Members and exhibitors took another step forward in 2017 as we head to our ultimate goal in 2018 of being recognised as The New Zealand Agricultural Show.

We invested money in:

- A seating stadium for the Endurocross arena
- Research on why visitors chose to attend the Show and what they enjoyed
- New carpark layouts
- More money on parking staff to manage traffic inside the grounds
- Brand development and engaging local and central Government in our plans for a Science and Innovation showcase

Our objectives for 2018 are to launch our new brand and deliver on our role as New Zealand's largest agricultural show. Our General Committee are committed to growing their A&P events and doing everything we can to support the A&P movement in NZ.

I would like to acknowledge the tremendous support of our sponsors across the Show from the donation of ribbons, the decades of support from local businesses like Ballantynes and our strategic partners the Christchurch City Council, Air Rescue Trust, ASB, Vero, Fonterra and Rata Foundation.

Working alongside our President Peter Gilbert was a great privilege and I would like to thank him for his significant contribution to the Association and the successful running of the 2017 Show.



Notes to the Financial Statements

For the Year Ended 31 December 2017

Note 1 - Statement of Accounting Policies

Reporting Entity

The Canterbury Agricultural & Pastoral Association is a Society governed by the Agricultural & Pastoral Societies Act 1908.

Canterbury Agricultural & Pastoral Association is registered as a Charitable Entity under the Charities Act 2005. Registration Number CC39172.

Note 2 - Statement of Compliance and Basis of Preparation

The financial statements have been prepared in accordance with generally accepted accounting practice in New Zealand. They comply with the PBE Accounting Standards as appropriate for Tier two not-for-profit benefit entities. As a registered charity, The Canterbury Agricultural and Pastoral Society is required to prepare financial statements in accordance with NZ GAAP as specified in standard XRB A1. The Association is a Tier Two reporting entity as it has expenditure less than \$30m and greater than \$2m.

Measurement Base

The financial statements have been prepared on the basis of historical cost except for the following material items in the statement of financial position:

- Buildings are stated at valuation
- Livestock is measured at market value

These financial statements are presented in New Zealand Dollars (\$), which is the Association's functional currency. All amounts have been rounded to the nearest dollar, unless otherwise indicated.

Going Concern

The financial statements have been prepared on a going concern basis.

Note 3 - Specific Accounting Policies

a) Depreciation

Depreciation has been charged on the basis of cost or valuation, at rates based on the expected economic life of the asset.

The following rates have been used:

Buildings	2 - 6% SL
Furniture & Fittings	8 - 40% DV
Office Equipment	10 - 67% DV
Plant & Machinery	2 - 67% DV
Motor Vehicles	10 - 30% DV

The depreciable amount of an intangible asset with a finite useful life shall be allocated on a systematic basis over its useful life.

The following rates have been used:

b) Valuation of Property, Plant & Equipment

Land and buildings (not including the Saleyards buildings), are included at depreciated replacement cost, due to the specialised nature of buildings. Other assets are stated at cost less depreciation to date. Property,

plant & equipment are written down immediately if an impairment in the value of the asset causes the recoverable amount to fall below carrying amount.

c) Trade Debtors

Debtors are valued at net realisable value after due allowance for doubtful debts.

d) Leases

Payments made under operating leases are recognised in the Statement of Financial Performance on a basis representative of the pattern of benefits expected to be derived from the leased assets.

1. Key terms of the Saleyards' lease are:

- In the current financial year, the rental for the premises is an amount equal to the principal and interest payments on the loans from the BNZ bank, therefore those loans have been extinguished this year. Rental payments from the tenants have ceased.
- Certain expenses designated as property expenses are the responsibility of the Association through to the year 2017, up to a limit of \$40,000 plus GST per annum. Any amounts over this are reimbursed by Canterbury Sale Yards (1996) Limited.
- Beyond 2017 and for so long as Canterbury Sale Yards (1996) Limited has renewed its lease, rentals shall be zero. Canterbury Sale Yards (1996) Limited assumes responsibility for all outgoings including repairs and maintenance, property expenses, etc., subject only to an apportionment based on the availability of the premises to the Association.
- Canterbury Sale Yards (1996) Limited has the right to claim nine rights of renewal, each for 20 years – potentially a further 180 years.
- In the event that the lease is not renewed, all ownership and occupancy benefits and costs revert to the Association.

2. Saleyards Lease

The Saleyards lease meets the definition of a "Finance Lease" under Accounting Standards. The Standard requires that the economic substance of the transaction be reported in the accounts, rather than emphasising the legal ownership. An asset equal to the present value of the future minimum lease payments receivable is recognised for land and buildings leased to third parties by way of finance lease. Each lease payment received is apportioned between finance income and the reduction of the outstanding asset. The interest income component of finance lease payments received is recognised in the statement of financial performance using the effective interest rate method. In practice this means that payments received under finance leases are recognised in the statement of financial performance such that the value of the income recognised is equivalent to the value of the variable interest repayments made on loans from the BNZ Bank. These loans are effectively to be repaid by the Canterbury Sale Yards (1996) Limited in the form

of future rentals. The Association's gross investment in finance leases and the amount of unearned finance income has not been disclosed, as it cannot be calculated owing to the variable nature of the interest repayments on loans from the BNZ Bank, on which the lease payments are calculated. The unguaranteed residual value of the leased assets cannot be calculated because the potential length of the lease including all available renewal terms cannot be ascertained.

e) Valuation of Livestock

Livestock has been valued using market value.

f) Changes in Accounting Policies

Livestock is now valued at market value instead of cost.

g) Income Taxation

The entity is exempt from income taxation.

h) Revenue from exchange and non-exchange

Transactions Revenue from exchange Transactions Service

Revenue from services rendered is recognised in the statement of financial performance when the service is provided.

Sales of goods

Revenue is recognised when the significant risks and rewards of ownership have been transferred to the customer, recovery of the consideration is probable, the associated costs and possible return of goods can be estimated reliably, there is no continuing management involvement with the goods, and the amount of revenue can be measured reliably. Revenue is measured net of returns, trade discounts.

Interest income

Interest income is earned for the use of cash and cash equivalents or any amounts due to the association. Interest income is recognised in the statement of financial performance as it is earned. Interest income is accrued using the effective interest rate method.

The effective interest rate exactly discounts estimated future cash receipts through the expected life of the financial assets to that asset's net carrying amount. The method applies this rate to the principal outstanding to determine interest revenue each period.

Revenue from exchange Transactions

Non-exchange Revenue

Non-exchange transactions are those where the association receives value from another entity (e.g. cash or other assets) without giving approximately equal value in exchange.

Inflows of resources from non-exchange transactions, other than services in-kind, that meet the definition of an asset are recognised as an asset only when:

- It is probable that the association will receive an inflow of economic benefits or service potential; and
- The fair value of can be measured reliably.

Inflows of resources from non-exchange transactions that are recognised as assets are recognised as non-exchange revenue, to the extent that a liability is not recognised in respect to the same inflow.

Liabilities are recognised in relation to inflows of

resources from non-exchange transactions when there is a resulting present obligation as a result of the non-exchange transactions, where both:

- It is probable that an outflow of resources embodying future economic benefit or service potential will be required to settle the obligation, and
- The amount of the obligation can be estimated reliably.

The following are the specific recognition criteria in relation to the associations non-exchange transactions.

Grants and donations

Payments received under grants are recognised in the Statement of Financial Performance upon fulfilment of terms and conditions attached to each individual grant.

Donated Services

The association sometimes receives the donated services from volunteers. The association has elected not to recognise these services as they are difficult to measure reliability.

i) Related parties

The association regards a related party as a person or an entity with the ability to exert control individually or jointly, or to exercise significant influence over the association, or vice versa. Members of key management are regarded as related parties and comprise the directors of the association.

The Association has operating lease commitments for a Ricoh photocopier and a Holden Colorado motor vehicle. In 2016 The Association entered into a 5 year fixed lease with Ricoh for \$43,200. In 2001 the Christchurch City Council acquired the Canterbury Agricultural Park land. The Association has entered into a license for 100 years from 1 April 2001 with the Christchurch City Council to occupy 90.14 hectares of that land for one month in each year. The Association has also entered into a lease for 20 years from 1 July 2001 with the Christchurch City Council with respect to 2.03 hectares of that land. The rental cost of the land is based on the actual costs incurred for that year.

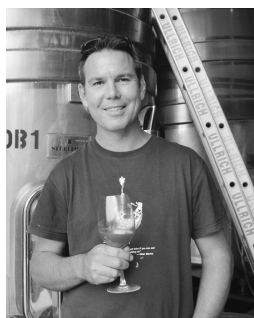


NEW ZEALAND AROMATIC WINE COMPETITION

It starts in the vineyard and ends up at the winery for the final step." Mr Wood chose to enter with three reds; the Obsidian Reserve Syrah 2015 and two cabernet blends (Obsidian Reserve 'The Mayor' 2013 and Obsidian Reserve 'The Obsidian' 2015).

"I think the wines that have really put Waiheke Island on the map are Bordeaux-style wines, so I decided to enter with cabernet blends that demonstrate what Waiheke is capable of producing. I also chose the 2015 Obsidian Reserve Syrah as a good example of what Waiheke can produce in a reasonable year."
